

## **Minutes of a meeting of Hinderwell Parish Council 8<sup>th</sup> August 2024, 6.45pm at St Hilda's Old School, Hinderwell**

### **2024:08-00 Those Present**

Cllr I Walker, Chair. Cllrs: Smith, Brooker, Jackson, Dorgan, Kilpatrick, Wilson and Ellis.  
Mrs C Barker, Clerk. One member of the public.

### **2024:08-01 To receive apologies for absence and approve reasons for absence**

Cllrs I & J Longster, Edean and Buck; reasons accepted. Proposed Cllr Jackson Seconded Cllr Dorgan.

### **2024:08-02 Declarations of interest**

None.

### **2024:08-03 Minutes of previous meetings**

The minutes of the July meeting of the Council were accepted as a true record. Proposed Cllr Smith, Seconded Cllr Jackson.

### **2024:08-04 Matters arising from previous minutes**

Remembrance Day signs: hopefully can be loaned from NYC Highways.

No Cold Calling Zone, Hinderwell – Letters gone out locally so will be legal soon.

Clerk had asked about including Staithes in this Zone -but needs an active Neighbourhood Watch scheme in place. HPC to ask via Facebook if anyone in Staithes is willing to set up and run NHW.

### **2024:08-05 Report from North Yorkshire County Councillor David Chance**

Not present and no apologies received.

### **2024:08-06 Planning Matters**

NYM/2024/0509: The Loft, Runswick Bay – much reconstruction incl windows- No objection

### **2024:08-07 Finance: Authorisation of payments**

Payments totaling £3922.94 were approved. Proposed Cllr Dorgan, seconded Cllr Jackson.

Chairman circulated the Quarterly financial spreadsheet. Clerk advised that the External Audit report had been returned and HPC passed with no issues.

### **2024:08-08 Northern Powergrid Presentation re Staithes**

An update was given to the meeting on works achieved since March. They plan to return to the village 16.09.24. Work will be close to Poplar House, where a sub station is located. Work will be on High Street, including Chapel Yard – which will be a difficult area. They will work 9am - 4pm and two traffic management staff will be present to maintain access for shops/residents/deliveries. Work will stop over the Christmas period. Letters will go out to properties in the next 7-10 days to advise of planned works and HPC to publicise via Staithes Facebook.

IW & AS asked questions about possible works at rear of Black Lion, but NPG will not be working in this area.

### **2024:08-09 Hinderwell Play Park update**

New signage now installed and naming it the "Beth Mead Play Park" has been very well received.

Clerk had sought 4 quotes for fencing work and received two back. Cllrs voted by a majority to accept the cheaper quote. Cllr Walker and Allotment holders will remove the old fence saving HPC £500.

### **2024:08-10 Staithes Play Park update**

Cllr Kilpatrick reported that they were awaiting a visit from 'HAGS' to see if any equipment could be re-used in new park. The survey is going well but needs a subscription paying to allow it to continue. Cllrs voted to spend £90 on a 6 month subscription. Proposed Cllr Walker, seconded Cllr Dorgan - all in favour. Problems as still no response from NYC's Matthew Smart and Kate Dawson. Chairman advised to get Cllr D Chance involved. Chair to do a Facebook post asking for more surveys to be completed.

### **2024:08-11 Boulby 106 Funding**

Clerk has received approval of HPC's application for grant of £1000 to pay for 5,000 daffodils. Clerk awaiting quotes for information boards in both Staithes bus shelters and an information lectern at the Barrass Upper Garden.

Cllrs Walker and Smith had visited Staithes museum re photos for these info boards and visited Land of Iron. Clerk to ask ICL Boulby for up to date photos of their mine.
