NYM/2024/0588: 6 The Old Stubble, Staithes – first floor and rear extensions – Objection because
of over-development of site, prominent location within village and proposals will not enhance the
property at all – poor vehicular access along a well-used footpath.

NYM/2024/0589 6 The Old Stubble, Staithes – demolish single garage and construct double
garage with holiday let above – Objection, same reasons as above

NYM/2024/0599: 140 High Street, H'well – creation of driveway – No Objection-Support proposal

Staithes – N Powergrid working in lower village updating electric cables – in Chapel Yard area.
Staithes – Chapel Yard, blue cobbles – Clerk to try to find some more for N Powergrid to use.
Staithes – Footbridge in dire need of painting and serious repairs – Boulby 106 money might help?
Responsibility of Redcar & Cleveland Council – Clerk to make contact.
A174 H'well/Staithes – Overgrown hedges both sides – Clerk to report to NYC Highways and to get a price for HPC to pay for its cutting back.
Seton Hall Corner- blocked Drains caused flooding at in recent storms – Clerk to report to NYC.
Rosedale Lane, Port Mulgrave, mud on road.
